Dear Rishabh Yadav,

Congratulations on your success in the application process to become a BAU International University, Batumi student. This letter is to inform you that you have been conditionally accepted to one-cycle higher education program in **Medicine**. The university will begin the enrollment process only for applicants who **pass the NEET exam**.

Upon payment for document recognition in the amount of 200.00 US dollars university will start document recognition process in the ministry of education of Georgia.

Upon payment of a deposit i.e. 2,400.00 US dollars towards your early tuition fee of 4,800.00 USD you will receive an official acceptance letter from the university, which will help you get a student visa to Georgia at the nearest Georgian Consulate. This non-refundable deposit will be considered as a guaranty of your intent to enroll at BAU and deducted from the tuition fee at registration.

The deposit will be only refunded in the following cases:

- a) **If you can not get visa (You should provide a proper paper proving rejection from the consulate);**
- b) **If your documents are not recognized from the Ministry of Education of Georgia.**
- c) **If you are not allowed to cross the border of Georgia (Problems with borders of transfer countries will not be taken in to consideration);**

Note:

- **In case of any above mentioned problems you should prove it with the proper papers otherwise the deposit will not be refunded!**
- **University will charge expenses for document recognition in the amount of 200 US dollars from the deposit and it will be non-refundable even though you face the above stated problems.**

This conditional acceptance letter will be invalid if the application fee amount of 200.00 US dollars is not paid in a period of 10 days from receiving the letter. Please note that this is a conditional acceptance letter for prospective international students, and **cannot be used to apply for a Student visa**. Once the deposit is wired to BAU International University, Batumi (details given in the next page), a copy of the bank receipt must be submitted to admissions@bauinternational.edu.ge

The applicant is required to submit an official transcript(for transfers) or official high school graduation certificate GSE A level/12th grade (for freshmen) from his / her last university or high school before the start of the academic year. Without submitting an official transcript or high school graduation certificate, the University will not enroll a student in the course agreed upon by Conditional Acceptance Letter.

The applicant assumes full responsibility for the correctness of the documentation submitted by him. In case of discrepancies between the documentation submitted during the registration and the official transcript or high school graduation certificate submitted later, the University imposes full responsibility on the applicant. In the case of such a (continued on the next page)

discrepancy, the information presented in the high school graduation certificate or official transcript will be considered preferable to the University.
