has been confirmed for admission to the Bukhara State Medical Institute named after Abu Ali ibn Sino, Republic of Uzbekistan, in the General Medicine program of the 1st year in English medium starting the 2025-2026 academic year for the September intake (Fall session).

Bukhara State Medical Institute named after Abu Ali ibn Sino is recognized by the Ministry of Higher Education and the Ministry of Health of the Republic of Uzbekistan, and the institute is listed in the World Directory of Medical Schools of the World Health Organization.

In order to become a student of the BSMI, the applicant, after successfully passing the interview, must pay **50% of the annual fees within 10 days from** the date of issuance of this letter to the appropriate bank account in order to confirm enrollment and to start the VISA Process. The successful candidate, after receiving the STUDENT VISA issued by BSMI, must arrive at BSMI **before the start of the relevant semester** to complete the process of signing the contract.

The contract for study between the above-mentioned student and the Institute will be signed after his/her arrival, submitting appropriately legalized original documents (with Apostille stamp), an interview with the international department staff

or the foreign student's faculty staff, and completing all necessary procedures for enrollment in the institute.

Note: It should be mentioned the following:

1. Students must immediately obtain temporary registration at their place of residence **within 3 working days after arriving in Uzbekistan.**

2. Students (applicants) must receive a **PINFL number (from the Center for the Provision of State Services (single window) of Bukhara** and, are registered on a certain **HEMIS platform** later will be able to download a contract (entering their data) using the official **link kontrakt.edu.uz.**

3. Undergo a **medical check-up** at the BSMI clinic.

4. Foreign citizens entering the educational institutions of the Republic of Uzbekistan shall undergo pre-test counseling and **AIDS/HIV examination**, which is **mandatory** for each foreign student.

5. **Health insurance** is also **mandatory** for the benefit of each student and for safety during their stay in the Republic of Uzbekistan.
