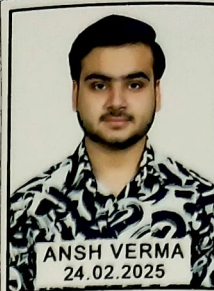

Declaration

- 3 For Post Graduate Courses (a) the applicant should have Bachelor's Degree from a recognised university (b) the right of selection is reserved with the Rector of the University abroad based on the applicant's previous academic performance.
- 4 The Applicant shall submit Notary verified photocopy of his/her academic certificates and mark sheets along with the application form. Once the University accepts the application, the applicant is required to produce original documents for the Apostille from the Ministry of External Affairs.
- 5 The selected applicant has to enter into an agreement with Study Nation 360 Pvt. Ltd. after paying the application fee.
- 6 The applicant once selected, should make arrangements to obtain a passport on their own, in case not available.
- 7 If any information provided in the application form by the applicant is found to be false or incorrect, such application shall be rejected and suitable action is liable to be taken by the University against the applicant.
